## **ESDs and the Student Success Act**

The Student Success Act (SSA) passed by the 2019 Legislature represents the first significant investment in Oregon's school system since the passage of ballot measure 5 in 1990. Meeting students' mental and behavioral health needs and increasing academic achievement for all students are its two main goals. To achieve these goals, funding can be used for expanding instructional time, student health and safety, class size and case load reduction, and provisions for a well-rounded education to include early literacy, middle school programs, and broadening curricular options.

School districts will need to complete a plan to access SSA funds. The plan must demonstrate community and stakeholder engagement in assessing the needs of the community. Once these needs are identified, they can be prioritized to receive funding. The plan requires approval by the local school board before it can be submitted to the Oregon Department of Education (ODE).

ESDs were also written into the SSA legislation. Their charge is to provide technical assistance in the development and writing of the local district plans, supporting those plans as they are implemented, and aiding coordination of coaching for those districts designated to receive such support. In the 2019-20 biennium, ESDs will receive \$24,000,000 from the Statewide Initiatives Account. This funding will be allocated as a percentage of the total ADMw of all ESDs. Expenditures by individual ESDs may take place beginning September 1, 2019 for allowable uses; however, funds will not be available until May 1, 2020.

Each ESD must complete a regional plan based on local district needs and targets in order to receive funding. The plan for ESD expenditures will be developed by the ESD's local school districts and will be adopted and amended as a part of the local service plan process and timelines. Each ESD must submit an annual report to the department that describes how the ESD grant funds were expended. Finally, each ESD must include an evaluation of the education service district's compliance with the plan from the superintendent of each school district that participated in the development of the plan.

## **Elevate Lane County Externships**

Elevate Lane County is Lane County's responsive programming to the need for

more career connected learning opportunities for students and educators. Launched in 2017, they have connected more than 7,000 middle and high school students with industry outside of the classroom, and have supported 36 educator externships, resulting in more than 5,000 professional development hours.

Leveraging the high level of engagement by industry partners, and the interest of component school districts, these externships have focused on high demand, high wage, STEM-related opportunities due to the expected growth of STEM occupations. This work-based learning pathway is a key component in developing students who are in touch with the demands of the workplace and the skills, both technical and professional. Educators who are exposed to the culture and values of an industry become more prepared to implement curriculum that is beneficial to student preparation. These students find:

- Relevance: Externships provide educators with direct access to current, relevant projects
  occurring in the industry where many of their students may make their careers. This access
  can inform the curriculum in ways that no other experience can.
- **Rigor:** With this current information, the expectations of course curriculum can begin to match industry expectation in grade-level appropriate ways.
- Relationships: This in-depth, multi-week learning experience creates lasting relationships between educators and industry partners that can develop networks of support and greater career-learning connection for educators and students.

Educators who are interested in participating apply during the month of February, are screened for selection in March, complete an orientation and industry assessment in April, and are matched with one or two companies in May. Together with industry partners, staff orchestrate an industry mentor orientation, educator orientation, two summer lunch checkins, two journal opportunities, and a required curriculum connection prior to entering the classroom in the fall.
